

## YMCA 'Spring Reset Challenge' - TERMS AND CONDITIONS (Terms)

### 1. OFFER AND ELIGIBILITY

- a. This 'Spring Reset Challenge' promotion (**Promotion**) is offered by Victorian YMCA Community Programming Pty Ltd (ABN 75 092 818 445) of 502/990 Whitehorse Rd, Box Hill VIC 3128 (**YMCA**).
- b. By participating in the Promotion, you agree to be bound by these Terms.
- c. The Promotion is available at Carlton Baths, North Melbourne Recreation Centre and Kensington Community Aquatic and Recreation Centre (**Participating Centres**) between the dates of 5 October 2026 to 29 November 2026 (**Promotion Period**).
- d. To be eligible for the Promotion, participants must:
  1. Be an existing Health and Wellness member at a relevant Participating Centre during the Promotion Period
  2. Be aged 18 years or over; and
  3. Comply with these Terms and Conditions.
- e. The Promotion is not valid in conjunction with other offers, unless approved in writing by YMCA.

### 2. COMPETITION TERMS

- a. If you meet the criteria set out in clause 1(d), you will be eligible to enter the Promotion.
- b. To qualify, you must be 18+ years old.
- c. The Promotion is only available at Participating Centres.
- d. Members must complete all eight challenge activities during the Promotion Period and have each activity validated and marked off by YMCA staff on their challenge card.
- e. Completed challenge cards must be returned to Reception by Sunday 6 December 2026.
- f. YMCA reserves the right to verify activity completion and validate all entries prior to awarding prizes.

- g. Employees of YMCA and their immediate families are not eligible.

### 3. PRIZES

- a. **Major Prizes:** Three winners from each Participating Centre will be selected at random from all eligible entries received during the Promotion Period.

Prizes:

- a 1<sup>st</sup> prize – 3 months free membership
  - b 2<sup>nd</sup> prize – 1 month free membership
  - c 3<sup>rd</sup> prize – Prize Pack
- b. The contents of the Prize Pack will be determined by the Participating Centre and may vary between centres.

- d. Winners will be randomly drawn and contacted on Monday 7 December 2026.
