# YMCA 'KCARC PRESALE' PROMOTION - TERMS AND CONDITIONS (Terms)

### 1. OFFER AND ELIGIBILITY

- a. This 'KCARC Pre-Sale' promotion (**Promotion**) is offered by Victorian YMCA Community Programming Pty Ltd (ABN 75 092 818 445) of 502/990 Whitehorse Rd, Box Hill VIC 3128 (**YMCA**).
- b. By participating in the Promotion, you agree to be bound by these Terms.
- c. The Promotion is only available at Kensington Community Aquatic and Recreation Centre (KCARC) (**Participating Centre**) between the dates of 3 September 2025 to 13 October 2025 (**Promotion Period**).
- d. Offer stages:

This promotion uses a series of decreasing stages based on number of memberships sold during this period. Stages will change when the membership unit limit is met, and current offer availability will be shared on the centre website.

- e. Membership offer and unit limits:
  - i. \$0 joining fee + 6 weeks free **150** units
  - ii. \$0 joining fee + 4 weeks free **300** units
  - iii. \$0 joining fee + 2 weeks free no limit
- f. To be eligible for the Promotion:
  - 1. You must not be an existing member at the relevant Participating centre; and
  - 2. You must become a Member at the Participating Centre and commit to a minimum contract period with YMCA of 6 months within the Promotion Period (offer i and ii).
  - 3. If you do not wish to lock into a 6-month contract, you may sign up for the \$0 joining fee + 2 weeks free offer.
- g. For the avoidance of doubt, the Promotion does not apply if you sign up for swimming lessons or other program memberships at the Participating Centre.
- h. The Promotion is not valid in conjunction with other offers, unless approved in writing by YMCA.

#### 2. SIGN UP TERMS

a. If you meet the criteria set out in clause 1(d), we will waive the joining fee and offer weeks free that would otherwise apply when you join up as a member at the Participating Centre.

- b. All other applicable fees and charges in respect of the membership will be payable in accordance with the applicable membership terms. Your membership will otherwise be governed by such membership terms.
- c. The Promotion is only available at Participating Centre.

- d. Minimum commitment terms
  - 1. 6-month contract at Kensington Community Aquatic and Recreation Centre.
  - 2. To quality, you must be 18+ years old and a new member.
  - 3. A photo ID is required for entry.
- e. The Promotion is only available at the Participating Centre.
- f. All other applicable fees and charges in respect of the membership will be payable in accordance with the applicable membership terms. Your membership will otherwise be governed by such membership terms.

- Any dispute or situation not covered by these terms, will be resolved by YMCA management in a manner it deems to be fair (acting reasonably)
- d. These terms are governed by the laws of Victoria, Australia.
- e. Members will be bound by their terms of membership with YMCA. To the extent of any inconsistency between the terms of membership and these Terms, these Terms will take priority.
